STALLION SERVICE AGREEMENT

The Stallion owner accepts the Mare _____

In accordance with the terms and conditions as stated below and payment of the service fee of: **\$1,650** (inc GST)

TERMS AND CONDITIONS

1) A non-refundable booking fee of 10% of the service fee is payable when the Mare is booked to be covered by a Sire at River Hills and your Mare will not be booked until the booking fee is received.

2) Your Mare will not be covered until the service agreement is signed and booking fee has been paid. Send to:

3) Free return

The Mare owner will be entitled to a free return if the Mare aborts the foal, the foal is stillborn or dies naturally within 24 hours of foaling.*

*A veterinarian's certificate is required.

4) The Mare owner warrants and agrees:

a) that they are aware the Stallion is standing at River Hills Stud Farm,
2 Friedland Road Bollier via Kandanga Queensland;

b) that they will contact the Stallion owner on 0417 955 469 to arrange for the agistment of the Mare or for a 'WALK-ON' service, at least three days notice is required for walk-ons;

c) that the service agreement will be lodged and the booking fee paid prior to the Mare arriving at River Hills Stud Farm;

d) that they are the registered owner or authorised agent of the owner of the Mare with the Australian Stud Book and at Law are able to enter into this agreement legally;

e) that they are responsible for all transport costs to and from the Stud for the Mare and its progeny, for the purposes of this Agreement;

f) that any and all veterinarian bills and agistment costs relating to this agreement will be passed on to the Mare owner or their agent and be paid in full, prior to the Mare leaving the property – unless otherwise agreed in writing;

g) that they are responsible for all **insurance arrangements** for the Mare in relation to this contract.
